2. Documents required at the time of online Admission and Physical verification

- i) Valid NEET (U.G) 2023 score card.
- ii) Recent colour passport size photographs (to be uploaded)
- iii) Class 10 marksheet and certificate.
- iv) Class 12 or equivalent marksheet and certificate.
- v) Adhaar card/Voters ID card/Passport/Driving license as identification proof.
- vi) Medical certificate (only prescribed form should be used which is available at the institute website).

3. The inter-se-merit of candidates for tie-breaking

In case of two or more candidates obtain equal marks/percentile scores in the NEET (UG) - 2023, the inter-se-merit shall be determined as follows:

- a) Candidate obtaining higher marks/percentile score in Biology (Botany & Zoology) in the Test, followed by,
- b) Candidate obtaining higher marks/percentile score in Chemistry in the Test, followed by,
- c) Candidate obtaining higher marks/percentile score in Physics in the Test, followed by,
- d) Candidate with less proportion of the number of attempted incorrect answers and correct answers in all the subjects in the Test,
- e) Candidate with less proportion of a number of attempted incorrect answers and correct answers in Biology (Botany & Zoology) in the Test, followed by,
- f) Candidate with less proportion of a number of attempted incorrect answers and correct answers in Chemistry in the Test, followed by,
- g) Candidate with less proportion of a number of attempted incorrect answers and correct answers in Physics in the Test

4. Admission Process and Counselling:

- a. Admission shall be strictly based on the merit of valid NEET (U.G) 2023 score only.
- b. Short listed candidates shall be called for online counselling based on the merit. They shall select the program of their choice depending on the availability of seats.
- c. Candidates who failed to attend counselling on the notified date shall forfeit their claim for admission.
- 5. If any candidate gets admission on the basis of false information/improper means or on the basis of false mark- sheet/certificates, his/her admission will be treated cancelled and legal action will be taken against him/her under Indian Penal Code (IPC). Candidates are advised to read the admission brochure carefully before applying for admission. And 'also, to check the Institute website regularly for any update
- 6. The prospective candidates are advised to keep visiting the RIPANS website regularly for announcements, notices and updates, because no separate information shall be sent to any prospective candidate.
